General Expectations

- Volunteers will be expected to be punctual & present for scheduled shifts, if you can't make it in please inform the shop manager at least 1 hour before your scheduled time.
- Volunteers in the shop & at events will be expected to be friendly and knowledgeable towards customers.
- Volunteers in remote positions will be expected to complete projects by the assigned deadlines, & all work must be done by the volunteer themselves (AI use is prohibited.)
- Active volunteers in good standing will receive 50% off all purchases (discount will need to be approved by management.)
- Volunteers will be considered "active" for 30 days following their last completed shift/project; "good standing" status may be revoked for failing to meet general expectations, or any other reason management may see fit.

Release and Waiver of Liability

The volunteer understands that the activities may include physical labor or other circumstances that may result in personal injuries. The volunteer hereby freely, voluntarily, and without duress executes this release under the following terms:

- Volunteer does hereby release and forever discharge and hold harmless Ari's Art Exchange and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may hereafter arise from volunteer's activities with Ari's Art Exchange. Volunteer understands that this release discharges Ari's Art Exchange from any liability or claim that the volunteer may have against Ari's Art Exchange with respect to any bodily injury, personal injury, illness, death, or property damage that may result from volunteer's activities with Ari's Art Exchange, whether caused by the negligence of Ari's Art Exchange or its officers, directors, employees or agents or otherwise. Volunteer also understands that Ari's Art Exchange does not assume any responsibility for or obligation to provide financial assistance or other assistance, including, but not limited to, medical, health or disability insurance in the event of injury or illness.
- Volunteer does hereby release and forever discharge Ari's Art Exchange from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the volunteer's activities with Ari's Art Exchange.
- The volunteer understands that the activities may involve work that may be hazardous to the volunteer, including, but not limited to, working in a retail setting, lifting heavy objects, cleaning with a variety of products, or transportation to and from the work site. Volunteer

hereby expressly and specifically assumes the risk of injury or harm in the activities, and releases Ari's Art Exchange from all liability for injury, illness, death or property damage resulting from the activities.

- Volunteer does hereby grant and convey unto Ari's Art Exchange all right, title and interest in any all photographic images and video or audio records made by Ari's Art Exchange during volunteer's activities with Ari's Art Exchange, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- Volunteer expressly agrees that this release is intended to be as broad and inclusive as permitted by the laws of the State of Arizona, and that this release shall be governed by and interpreted in accordance with the laws of the State of Arizona. Volunteer also agrees that in the event that any clause or provision of this release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this release which shall continue to be enforceable.
